Pursuant to the Section 4 of the Tripura State Medical Council Act, 2010, it is hereby notify to all the Registered Medical Practitioner of the Tripura State Medical Council that in view to elect 07(Seven) members for the Council for the next 5 (five) years [2024-2029], election will be conducted as per following schedule.

The manner and procedure of election

- a) All registered members of the council are eligible to participate in the election.
- b) The members of the council are entitled to propose the name of any member of the Council and also second, provided one member of the council shall be entitled to propose or second only one name.
- c) Nomination papers shall be submitted in prescribed form. The copies can be had from the Council Office at Dr. P.B. Das Memorial Building, Bidurkarta Chowmuhani, Krishnanagar, Agartala-799001. The nomination papers shall be sent in envelopes addressed to Returning Officer. The Tripura State Medical Council, Dr. P.B. Das Memorial Building (Ground Floor), Bidurkarta Chowmuhani, Krishnanagar, Agartala and superscripted "**Nomination for Election of 7(Seven) Members of the Tripura State Medical Council**".
- d) Under statute 4(i) relating to election to the authorities every candidate for election has to be deposit with the Council an amount of Rs. 500/- (Rupees Five hundred) only. Every nomination paper should be accompanied by a Demand Draft of **State Bank of India, PBB Branch, Colonel Mahim Thakur Sarani, Agartala** or **UCO Bank, TRTC, Krishnanagar Branch** for payment of this deposit in favour of the **Tripura State Medical Council**. A candidate shall not be deemed to be duly nominated, unless the deposit has been made.

- e) The nomination paper will be scrutinized on the appointed date and time fixed for the purpose in the office of the Returning Officer, Election for Tripura State Medical Council. Candidates or their Agents with an authorization letter may be present at time scrutiny. List of validly nominated candidates will be notified soon after the completion of the scrutiny.
- f) A candidate may withdraw his/her candidature by a notice in writing in the prescribed form, attested by two voters. Application for withdrawal of candidature should reach the office of the Returning Officer, Election for Tripura State Medical Council before the time fixed on the date notified for the purpose. The Final List of contesting candidates will be notified soon after the time fixed for withdrawal is over on the date & Time notified for the purpose.
- g) Election, if necessary, will be by personal ballot in accordance with the system of simple majority.
